Primary responsibility for leading Florida's K-12 career and technical education system, across 67 school districts, with more than 700,000 students enrolled, annually. Administered a \$500M dollar annual budget, including an additional ~\$120M dollars in grants, sponsored research, and discretionary workforce development funds.

Accomplishments

 education (Home | Get There FL) to raise awareness and increase enrollment in Florida's postsecondary
 career and technical education programs. Within the first two years, the campaign garnered an ad value
 of earned media estimated over \$2M dollars with 100,000 unique visitors to the website, over 40,000
 prospective students connected to a state college.
